4. Compliance Restrictions (Non-Advertising Acknowledgments Only)

5. Editorial Control

Real Recovery Podcast Inc. retains full editorial control over all podcast content, guest selection, storytelling, production decisions, and the placement and exact wording of sponsor acknowledgments. Sponsor shall have no authority to influence episode content, topics, guests, or messaging.

6. Payment Terms

7. Term and Termination

This Agreement applies to the specific sponsorship level selected in Section 2. The term of this Agreement will cover the agreed-upon episode(s) and/or event(s) associated with that sponsorship. Either party may terminate this Agreement with written notice. If termination occurs before fulfillment of all agreed recognitions, Real Recovery Podcast Inc. may, at its sole discretion, refund a portion of the sponsorship amount corresponding to unfulfilled acknowledgments.
