Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: dedicated to creating and distributing audio content focused on stories of addiction recovery and mental health awareness. Our primary activity involves producing regular podcast episodes that feature personal testimonies, expert interviews, and discussions aimed at supporting individuals and families dealing with substance abuse and mental health challenges. Additionally, the podcast engages in community outreach initiatives, including participating in and organizing events that support addiction recovery, as well as collaborating with other organizations to widen our impact. We plan to use our platform to raise awareness, facilitate access to resources, and support recovery efforts on a broader scale.
